1) OBJECT AND PURPOSE OF THE PROCESSING

PLAST S.r.I. (Tax code / VAT number: 00314090267), with registered office in Fontanelle (TV), Via I Maggio, no. 42; tel.: +39 0422 509511; fax: +39 0422 509515; e-mail: info@plast-srl.it (hereinafter also referred to as "**Owner of the Processing**" or "**Owner**"), in the person of the legal representative Mr. Rui Gilberto (Tax code: RUIGBR67B27C957A), born in Conegliano (TV), on 27/02/1967, informs the users of this website in accordance with EU Regulation no. 2016/679 (hereinafter referred to as "**GDPR**") and with article 13 of Legislative Decree no. 196/2003 (hereinafter referred to as "**Privacy Code**") on the method of personal data processing for **users** (hereinafter referred to as "**Data Subject**") who consult the website: **www.plastgroupsrl.com**.

Data processing only concerns the information published on the domain of PLAST S.r.l. and not the links published or contained therein.

During their normal operation, computer systems and software procedures used to operate this site acquire some personal data whose transmission is implicit in the use of Internet communication protocols.

This category of data includes IP addresses or domain names of computers and terminals used, URI/URL (Uniform Resource Identifier/Locator) of requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the server (successful, error, etc.) and other parameters concerning the operating system and the computer environment.

Apart from ensuring the correct use of web services, these data are also processed in order to obtain statistical information on the use of services (most visited pages, number of visitors per time slot or day, geographical areas of access, etc.) and to check the proper functioning of the services offered.

Navigation data do not persist for more than 12 months and are deleted immediately after aggregation. Cookies are not used for user profiling, nor are there other methods of tracking. Non-persistent session cookies are used only for the safe and efficient navigation of the site.

No data or information is collected in any way to directly or indirectly contact the users of the website to perform advertising or marketing activities.

No user profiling is carried out.

5) RIGHTS OF THE DATA SUBJECT

As a Data Subject, You have the rights set forth in Art. 7 of the Privacy Code and Art. 15 of the GDPR, namely the rights to:

- 1. obtain confirmation of the existence of personal data concerning yourself, even if not recorded yet, and their communication in intelligible form;
- **2.** obtain information on:
 - a) personal data origin;
 - b) purpose and method of processing;
 - c) procedure applied in case of processing via electronic instruments;
 - **d)** personal details of the owner, people in charge and representative designated in accordance with art. 5, paragraph 2 of the Privacy Code and art. 3, paragraph 1, GDPR;
 - e) subjects or categories of subjects to whom the personal data may be communicated or who may have access to them as appointed representative in the territory of the State, or responsible person;





- 3. obtain:
 - a) the updating, amendment or, when interested therein, the integration of the data;
 - b) the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention does not fulfil any purposes for which the data were collected or subsequently processed;
 - c) certification that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to protect;
- 4. oppose, fully or partially:
 - **a)** for legitimate reasons to the processing of personal data concerning yourself, even if in compliance with the purpose of the collection;
 - b) the processing of personal data concerning yourself for the purpose of sending advertising materials or direct selling or to perform market research or commercial communication, via automated calling systems without the mediation of an operator by e-mail and / or traditional marketing methods by telephone and / or post. It should be noted that the right of opposition of data subjects, as set out in point b), for direct marketing purposes by means of automated methods also extends to traditional methods. The possibility for data subjects to partially exercise their right of opposition remains unaffected. Therefore, data subjects may decide to receive communications either by traditional means or by automated communications, or neither of the two types of communication.

When applicable, You have the rights under Articles 16 - 21 GDPR (Right to rectification, right to be forgotten, right to restriction of processing, right to data portability, right to object), as well as the right of complaint to the appointed Authority.

You may at any time exercise the aforementioned rights by sending a registered letter with acknowledgement of receipt or an e-mail to the above-mentioned addresses of the Owner of the Processing.
